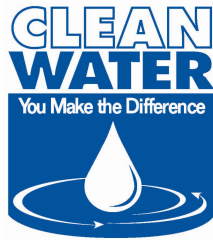


**Battle Creek Area Clean Water Partners**

  - o City is conducting IDEP monitoring. Tracking down an illicit discharge at Angell/Parish outfall.

- X. **Comments:**
  - o Wilkey (City of Springfield): Culverts are being replaced this summer at Lafayette and Tecumseh. Awaiting 399 permits. The City's MS4 permit was approved by EGLE.
  - o Clifton (Calhoun County Water Resources): The County continues to trap beavers. Approximately 60 have been trapped to alleviate homeowner flooding issues. The County's MS4 progress report was submitted and approved.
  - o Schumacher (Lakeview Public Schools): Bond updates include work on the football field, elementary school updates, Middle School work with an addition off Columbia Ave., changes to the Meijer and City stormwater BMPs.



- Schacht (Emmett Twp.): Emmett Twp. held a bulk waste cleanup event on June 11, 2022. Republic Services had a bulk truck and a 40 yd. container on site.
- Smith (Denso) 2,500 pollinator seed mix packets distributed to employees on Earth Day. The basketball/tennis court areas are being redone. They have a wildflower garden on site.
- Lewis (BCAMSC): 20 students participated in a cleanup on April 30, 2022 along the City's Linear path from BCAMSC to the Police station. 8-9 bags of garbage were collected. Beginning in the fall, he will have a class of 20-40 students looking for volunteer hours ~1 hr/week.
- Budreau (City of Battle Creek): Mentioned the City's compost project (Battle CreEQ Gold)
- McLaughlin (KRWC): KRWC will have a booth at Juneteenth Celebration on June 18 in Battle Creek; Event with Kalamazoo Area Math & Science Center students and Whitehouse Nature Center on July 6 at Morrow Lake. Looking for volunteers to help; KRWC received a grant for WQ monitoring equipment which will be available to loan out; "Dashboards" available on the KRWC website with data on fish contaminant levels, sediments and water quality.
