To undertake functions, objectives, and powers enumerated in Section 1 of Public Act 49 of the Public Acts of 1999, including the promotion of economic activity in the BID along Dickman Road and providing or contracting for the administration, security, and operation of the District, to include physical improvements and joint marketing.

Nine (9) members.

Term:

Three years, staggered.

- Two representatives, based on nominations from automobile dealerships in the BID
