<u>Authorization:</u>	Created and authorized by the City Commission pursuant to Act 197 of the Public Acts of 1975 of the State of Michigan. (Resolution of January 23, 1979.)
<u>Appointing Authority:</u>	City Manager with approval by City Commission. New appointees must be sworn in.
<u>Liaison:</u>	Ted Dearing, Assistant City Manager TEDearing@battlecreekmi.gov
<u>Purpose:</u>	To correct and prevent deterioration in the downtown development district; To encourage historic preservation; To authorize the creation and implementation of development and financial plans in the district; To promote economic in the district; To own, operate, and maintain the Kellogg Center and other facilities in the downtown deployment district; and To authorize the acquisition and disposal of interest in real and personal property.
<u>Membership:</u>	Eight (8) members plus Chief Executive Officer of municipality, with at least five (5) members having an interest in property located in the downtown district.
<u>Term:</u>	Four years, except in filling a vacancy, which term must be just for the unexpired time. (See By-Laws.)
<u>Special Requirements:</u>	None.
<u>Compensation:</u>	None, but reimbursement for actual expenses.
<u>Meeting Schedule:</u>	Quarterly and/or As Needed.
