



## **DOWNTOWN PARKING SYSTEM ADVISORY COMMITTEE**

**Authorization:**

Started by City Manager Aaron Marsh in 1975 (without a Resolution and chaired by the Director of Transportation) as an in-house Advisory Committee. Commission representation was not originally included in the committee makeup. The committee was formally created and authorized by the City Commission by Resolution 94 on April 14, 2020.

**Appointing Authority:**

Mayor appoints City Commission representative by Resolution. Businesses representative, owners and members at large are appointed by the City Manager in consultation with the Director of Public Works and the representative from the city's parking system administrator and approved by the City Commission

**Purpose:**

To advise city staff and the city's parking administrator on issues related to the municipally-owned and operated parking system.

**Membership:**

The Committee shall consist of a minimum of nine (9) and a maximum of fifteen (15) members. The Committee shall be composed of the following:

- A member of the Battle Creek City Commission
  - The Director of Public Works (Chair)
  - A representative from the city's parking system administrator
  - The Development Director for the City of Battle Creek
  - The General Manager of the Cereal City Development Corporation (or his or her designee)
  - The Chief Executive Officer of the Calhoun County Visitor's Bureau (or his or her designee)
  - The Battle Creek Chief of Police (or his or her designee)
  - Two (2) members of the public at large, who must be residents of the City of Battle Creek.

- Up to six (6) additional members, including property owners or representatives of businesses located in downtown Battle Creek.
