<u>Authorization:</u>	Resolution No. 22, adopted by the City Commission on December 6, 2016, established the Technical Review Committee.
<u>Appointing Authority:</u>	City staff members of the committee shall be appointed by the City Manager and the remaining committee members shall be appointed by each of the five Contributing Jurisdictions.
<u>Liaison:</u>	Rodney Clifton, Wastewater Superintendent RWClifton@battlecreekmi.gov
<u>Purpose:</u>	To provide review, input, and recommendations to the city and the City Commission regarding various aspects of the Wastewater Treatment system and rates.
<u>Membership:</u>	<p>The committee shall be comprised of the following:</p> <p>Two (2) representatives from each of the five Contributing Jurisdictions including:</p> <ul style="list-style-type: none">• either the Contributing Jurisdiction's manager/supervisor or one of its elected officials• one person having relevant engineering or other technical expertise <p>Five (5) representatives from the city including:</p> <ul style="list-style-type: none">• at least one elected city official• the Battle Creek City Manager or designee• the city's Plant Supervisor or designee• at least two people having relevant engineering or other technical expertise <p>Two Industry Representatives selected by a majority vote of the above members.</p>
<u>Term:</u>	Open-ended, with the exception of the chair who serves a limited term on a rotating basis. (See by-laws).
<u>Special Requirements:</u>	None.
<u>Compensation:</u>	None.
<u>Meeting Schedule:</u>	Quarterly and/or As Needed.
