Information for All Crime Victims

If you would like to be notified of an arrest and/or the release of the person arrested, call the law enforcement agency and inform them. If you are not notified of an arrest in your case, call the law enforcement agency.

The Michigan Constitution and Crime Victim Rights Act grant all victims of crime to the following rights:

- Be treated with fairness and respect for their dignity and privacy
- Be informed of the steps in the criminal justice process
- Be notified of all proceedings in the case
- Attend all court proceedings
- Have reasonable protection from the defendant throughout the criminal justice process
- Consult with the Prosecuting Attorney about the disposition of the case
- Address the court at sentencing, or submit a written impact statement to the court
- Restitution
- Information about the conviction, sentence, imprisonment, and release of the defendant
- Information on the appeals process and any appellate decision
